The Board of Education had athered in its usual meeting place in the Administration Building Monday at 8 o'clock but there is space for only a dozen guests there. As the building became jammed with teachers and other interested persons, the Board decided to move its meeting to the nearby Junior High library. It is estimated that there were around 130 of the 206 teachers present.

During the past week, at least six of the seven - mem-ber Board had decided upon a 7 mill levy. Board Trustee eter Zyistra, who calls him self the "minority" side of the Board, had sided with the PEA for higher salary adjustments, which would mean pushing the millege proposal up to 7.5 mills. In a prepared statement, Zylstra questioned the sincerity of the Board, charged them with lowering employee morale and bringing about abuse of the Citizens Committee when the committee delivered its report before teachers and others. He also questioned the need and cost of a curriculum director (which has now been postponed at least a year) and a 'super principal'' for the two junior highs, aided by two assistant principals. Zylstra asked that his report be entered into the minutes, but at the conclusion of the meeting asked that it be withdrawn after he seemed satisfied that there was harmony between the Board and PEA with the new proposal. Most of the Board members took turns stating their views and many of the teachers, plus a few interested citizens, spoke openly on the salary scale and related subjects Chief spokesman for the PEA was its president, John Donegan. By 11 p.m., it appeared that the PEA would not support a 7 mill levy, which would have given most teachers a \$200 to \$300 a year increase. The Board then asked to be excused for a caucus and 10 minutes later returned with the proposal for 7 mills during the first year and 7.5 mills for the next four years. Also included in the staff proposals are these: 1. The school district would pay one-half the cost of hospital-surgical insurance. 2. Starting Sept. 1, teachers would be paid on an "earned increment" basis, under which advancement in salary

Ordinance No. 286

AN ORDINANCE TO AMEND ORDI-NANCE NO. 236, KNOWN AS THE "PLUMBING CODE OF THE CITY OF PLYMOUTH".

THE CITY OF PLYMOUTH ORDAINS:

Section 1. Ordinance No. 236, as amended, the "Plumbing Code of the City of Plymouth" is hereby amended and numbered to read as follows:

Section 1001.7 of the Official Plumbing Code of the City of Detroit, being City of Detroit Ordinance No. 847-E, as amended, and as adopted by reference by the City Com-mission of the City of Plymouth on December 4, 1961, is hereby amended to read as follows:

Section 1001.7 ROOF INCREASES. Each waste or vent stack shall be increased to at least three (3) inch size at its roof terminal. All soil stacks or any waste stacks used in lieu of a fresh air vent shall be the same size as the vent stack except no roof extension shall be less than three (3) inch size at roof terminal.


Section 2204.1.1 of the above cited ordinance is hereby emended to read as follows:

Section 2204.1.1 NEW CONSTRUCTION. All soil, waste and vent and water distribution pipe in the plumbing and drainage system shall be subjected to a water test or air test when deemed necessary and re-quested by the Plumbing Department.

Section 1201.1 of the above cited ordinance is hereby amended to read as follows:

Section 1201.1 STORM WATER DRAINAGE. No storm water from all roofs, courts, paved or hard surfaced areas, shall be drained into the sanitary sewer. Section 2. This ordinance shall become operative and

effective on the 27th day of March, A.D. 1962. Made, passed and adopted by the City Commission of


throughout the year? None of the above is for extra pay, and in most schools these things are expected of the teachers and many are assigned either by the principal or a class advisor.

Teachers also must study for college classes they must take for credit in, order to gain their permanent certificate. The state requires all teachers to take 10 hours of credit courses within a fiveyear period after graduation from college. So, many of our younger teachers are busy fulfilling this requirement also our local Board of Education expects professional growth in teachers by additional work, either at college or in some other form.

So, in addition to teaching a full load during the day, many of our teachers are taking night classes at nearby colleges which require much preparation and work. Many of them also attend

summer sessions, which they pay for themselves since they are expected to keep up with the professional growth idea, however, after the 10-hour state requirement is met the teachers are paid ten dollars for each hour over the first ten — many schools pay for all the hours earned above an AB degree.

The purpose of the conference was to consider crucial issues in the teaching of read-





ing and the implications for instructional programs.

The main add ress was given by Dr. William D. Sheldon, president of the International Reading Assn. using the conference title "Crucial Issues in the Teaching of Reading." He pointed out that there is no one method that is right for every child, that there has been much research in what we can teach a five year old through his environment, through listening, and through kinesthetics, but there must be no pressure or frustration will be the result

He stated that research articles are written for other members of the profession and that the average readers are mislead through their misunderstanding. There have been over 5000 research studies made, but not more than 1000 are valid.

He stressed that when using new methods not to throw out the old ones but to use them together for to gain maximum benefits. And that the best procedure for reading is good instruction and instructors rather than the method.

The luncheon address, "A Linguistic Study of Children's Language and the Relation of Language to Reading" was given by Dr. Ruth G. Strickland, Professor of Education at Indiana University. She stated that no child writes better than he talks and we need to give more thought to oral speech.
