

## **College Trustees Accept New Plans** For 1-Story Library

Schoolcraft College's board of trustees have approved preliminary plans for the institution's re-designed library.

Earlier, the library had been included in the original complex of four intitial buildings, but for reason's of economy it was re-designed and now will be bid as a separate unit.

Ground-breaking for the three other buildings has been held and construction is underway.

The new plans for the college library call for a onestory structure compared to the original two-story building originally planned. It will seat 350 students, according to the architect, and will have stacks of 35,000 books.

Eight classrooms and various faculty offices are also included. As the college's enrollment increases, the classrooms will be converted into an additional wing for the library.

In other college matters recently, the trustees awarded an alternate contract which includes the construction of a radio and television tower.

Plans for a \$16,000 center court have also been accepted. The base bids let to date total \$1,742,781.
